- 2) The applicant agrees to be responsible for payment of all charges on the account made by their representatives.
- 3) Payment terms are net 30 days from date of invoice and purchases are subject to finance charges of 2% per month (24% per annum) on any balance over 30 days past due. Monthly account statements are sent by mail or can be accessed electronically with CDK Global AR Portal. A monthly e-mail notification is sent by CDK Global advising when a statement is available. Accessing the statement is the responsibility of the applicant and failure to access the statement does not relieve the applicant of any obligations regarding the payment of accrued finance charges.
- 4) The applicant agrees that payments shall first be applied to any unpaid finance charges and second to invoices, work orders, finance or lease payments.
- 5) Failure to comply with the terms of credit may result in the suspension or cancellation of credit privileges with Nortrux Inc. without notice.
- 6) Permission from the company must be obtained before any goods are returned for credit. A 15% restocking charge may be applied on goods returned when supplied as ordered. All special order items that are returned may be subject to the manufacturer's restocking fees, freight charges and conditions.
